**TO: Wyoming Independent Candidates for Partisan Public Offices**

**RE: Petition for Nomination – Placement on the General Election Ballot**

Wyoming Statutes 22-5-301 through 22-5-308 are controlling legislation. The petition shall be approved by the appropriate filing office prior to circulation. The statements below are only a summary and you should consult the statutes as cited.

An unsuccessful candidate at a primary election is not eligible for nomination by petition for the same office at the next general election.

A petition for nomination shall be filed with the appropriate filing office. Federal or state candidates file with the Secretary of State's office. Local candidates file with the county clerk.

**Statewide Office: Signatures Required.** A petition for a statewide office shall be signed by registered electors, resident in the jurisdiction and eligible to vote for the petitioner, numbering not less than two percent (2%) of the total number of votes cast in the state for U.S. Representative in the last general election. The number of signatures required for a statewide race is 4,833 for the upcoming 2014 election. (W.S. 22-5-304(a))

**County Office: Signatures Required.** A petition for a county office shall be signed by registered electors, resident in the jurisdiction and eligible to vote for the petitioner, numbering not less than two percent (2%) of the total number of votes cast in the county for U.S. Representative in last general election. (W.S. 22-5-304(b))

**District Office: Signatures Required.** A petition for a district office shall be signed by registered electors, resident in the jurisdiction and eligible to vote for the petitioner, numbering not less than two percent (2%) of the total number of votes cast for the office in that particular district in the last general election. If a district's boundaries have changed since the last general election, then the required number of petition signatures shall not be less than two percent (2%) of the number of registered voters in the current district boundaries at the close of day on the day immediately preceding the primary election. (W.S. 22-5-304(c))

**Filing Deadline: August 25, 2014.** You must file not less than seventy (70) days prior to the general election. A petition shall be circulated for signatures only during the calendar year in which the election for the office sought is to be held.

**Filing Fees:** \$200 – Candidates for federal and statewide offices.  
\$25 – Candidates for state legislative and county offices.
